SUMMARY OF PROCEEDINGS OF THE 38th ANNUAL GENERAL MEETING OF KLJ RESOUECES LIMITED AND DECLARATION OF RESULTS OF E-VOTING AND POLL THROUGH BALLOT PAPER(S)

The 38th Annual General Meeting ("the AGM") of the Members of KLJ Resources Limited ("the Company") was held on Saturday, the 28th day of September, 2024 at 10.00 A.M. at the Registered Office of the Company at 22, Ground Floor, Shanti Niketan Building, 8, Cammac Street, Kolkata – 700017.

Sh. Dilip Kumar Karn, the Chairman of the Board, Chaired the meeting. Smt. Kalpana Seth represented as a Chairperson of Stakeholders Relationship Committee and as a member of Audit Committee and Nomination and Remuneration Committee of the Board. The Chairman informed the members that Sh. Hemant Jain, Managing Director, Sh. Kamlendra Navratansingh Chauhan, Whole Time Director, Sh. Ram Parkash Makan, Director and Sh. Babulal Bhutoria, Director of the Company could not attend the meeting due to their preoccupations. Leave of absence was granted to M/s Deepti Chawla & Associates, Company Secretaries, New Delhi, the Secretarial Auditors of the Company and to M/s Kumar Chopra & Associates, Chartered Accountants, New Delhi, the Statutory Auditors of the Company, who had requested for the same.

Total 18 members attended the meeting in person including bodies corporate through their authorized representatives. Sh. Ajai Kumar Gupta, Company Secretary of the Company ascertained the quorum of the meeting. After ascertaining the requisite quorum, the Chairman called the meeting in order.

The Notice Convening the Annual General Meeting together with Director's Report and Auditor's Report were taken as read with the consent of the members. The Chairman informed that there were no qualifications, reservations or adverse remarks in the Auditor's Report.

The Statutory Registers, Proxy Registers and inspection documents were available during the meeting for inspection by the Members.
